WEBSITE PRIVACY POLICY

Your privacy is something that we take very seriously. We are providing this notice outlining our online information practices in an effort to further protect your privacy. We provide this notification on our website to make it easily accessible.

1. INFORMATION COLLECTION AND USE

In order to give our users and clients an experience that is relevant to their needs, we gather information about visits to our site. Through our site, we do not obtain credit card or medical information. 2. SECURITY

3. GOOGLE ANALYTICS AND COOKIES

4. COLLECTION AND USE OF PERSONAL INFORMATION OF CHILDREN UNDER AGE 13

We are dedicated to safeguarding children's privacy online. We will not knowingly collect any personally identifiable information from children under the age of thirteen (13) without first getting parental consent in compliance with the Children's Online Privacy Protection Act (COPPA). 5. TRANSFER OF DATA ABROAD

6. COMPLIANCE WITH LAWS AND LAW ENFORCEMENT

9. MEDICAL PRIVACY NOTICE

This section explains how we may use and share medical information about you, as well as how you can access this information. Please give it a thorough read.

A. Who Will Follow This Notice?

Every healthcare provider that treats you at any of our sites, including staff members, volunteers, and members of our organization, as well as all departments and operating units of our business, other employees, and business associates.

B. Your Medical Information

Your health-related information is mentioned in this section. This includes all personally identifiable information pertaining to your past, present, or future physical or mental health or condition, as well as details regarding payment and billing for the health care services you receive.

C. Our Pledge Regarding Medical Information

We are dedicated to protecting your medical information because we recognize how private it is. In order to make sure we are giving you high-quality care and to meet legal requirements, we keep a record of the services and treatment you receive. D. How We May Use and Disclose Medical Information About You

We will make an effort to provide some examples for each category of use and disclosure, however not all uses and disclosures will be included.

i. For treatment. Your medical information might be used by us in order to treat you or refer you to other healthcare providers. In order to coordinate the various services you require, your medical information may also be shared by several healthcare providers. After you leave our care, we might give your medical information to others outside of our offices and/or locations who may be involved in your care.

ii. For Payment. Your medical information may be disclosed to other parties so that we can bill them for the services and treatment you receive. For instance, in order for your health plan to reimburse us for the services rendered, they might require information regarding the therapy you underwent. In order to get prior approval from your health plan, we might also divulge information about your medical insurance.

iii. For Healthcare Operations Purposes. Your medical information may be used and disclosed by us for internal business operations, including business management, administrative tasks, legal and auditing duties, and insurance-related activities. Medical information may be used for process reviews or performance evaluations of our caregivers in order to ensure that all of our patients receive high-quality treatment. For review and educational purposes, we may also divulge information to medical professionals, nurses, technicians, and other staff members. In order to allow others to use this set of data to research healthcare and healthcare delivery without knowing the identity of a particular patient, we may remove any information that could be used to identify you. Your medical information may be disclosed under specific conditions to other healthcare providers for their use in their operations.

iv. Health Information Exchange. We may participate part in the Regional Health Information Organization (RHIO), which organizes the the electronic sharing of health data across our state's healthcare providers. For the purposes outlined in this Notice, we may electronically exchange your health information through RHIO. You are entitled to request that this exchange not use any of your personal information.

v. Individuals Involved In Your Care or Payment of Your Care. Your health information may be disclosed to a friend, relative, or somebody who assisted with the cost of your care.

vi. Notification. To tell a family member, personal representative, or other person in charge of your care of your whereabouts, general health, or demise, we may disclose your medical information. Additionally, we may release your medical records for certain disaster relief purposes.

vii. Contacts. It's possible that we'll get in touch with you to provide things like treatment alternatives, appointment reminders, or other benefits and services related to health that you might find useful.

viii. Worker's Compensation. For workers compensation or comparable programs, which offer benefits

for diseases or injuries sustained at work, we may disclose medical information about you.

ix. Mental Health Information.Certain conditions are imposed by state laws on the disclosure of mental health records. When these laws require us to reveal mental health information, we will obtain your specific authorization.

x. Drug & Alcohol Treatment Records. Certain drug and alcohol program records are subject to certain regulations. As mandated by Federal regulation 42 CFR, Part 2, we will get your express authorization before disclosing those records.

xi. Miscellaneous. For a number of additional reasons, we might use or share your medical information without your previous consent. We may disclose your medical information without your consent for public health purposes, reporting of abuse or neglect, health oversight audits or inspections, research studies, funeral plans, coroners investigations, organ donation, and emergencies, subject to specific limitations. Additionally, under certain legal requirements, in response to a request from law enforcement, for specialized government operations like military, correctional, or national security, in compliance with judicial court or administrative orders, or to avert a serious health threat, we may be required by law to disclose medical information. Mental health records may be subject to additional specific rules.

xii. Other Disclosures. Only with your written authorization will any additional uses and disclosures be done that are not mentioned above. For instance, the majority of uses and disclosures of psychotherapy notes, as well as uses and disclosures that amount to the sale of your medical information, require your explicit consent. Furthermore, unless we receive your signed authorization we will not use or disclose your medical information for marketing purposes. However, consent will not be required if: (a) aa communication happens face-to-face; (b) involve marketing gifts of nominal value. Your authorization is revocable at any moment, excepting circumstances in which we have depended on it or in which receiving health care services was contingent upon your authorization.

E. Your Rights Regarding Medical Information About You

i. Right to Inspect and Copy.When you make a formal request, you typically have the right to see your medical records in person or to have a copy sent to a person of your choosing. You are entitled to obtain a copy of your medical record in an electronic format and form if it is kept electronically in a specific record set. Under some conditions, we might reject your request. There is an appeal process available if you are refused access to your medical records.

ii.Right to Amend. You have the right to ask for an addendum to be added to your record by making a written request with your justification if you think the information in it is inaccurate or lacking. In certain situations, your request can be denied by us. If we reject it, we may give you written notice of our decision and your right to submit a statement of explanation.

iii. Right to an Accounting of Disclosure. You have the right to a list of the instances on which we have disclosed your health information to parties other than those involved in your care, the hospitals directory, treatment providers, payment processors, or healthcare operations, or in cases where such a disclosure was expressly approved. You must send a written request to our Support Department in order to obtain an accounting of disclosures.

iv. Right to a Paper Copy of this Notice.You are entitled to a printed copy of this notification if it was provided to you electronically. You have the right to ask that we deliver any such communications containing protected health information to an alternate address or by an alternative means. The person specified in Section 10 below must receive a written request for this. We are only required to accommodate reasonable requests. In your correspondence, please indicate exactly how you would like us to get in touch with you. If you would like it sent to a specific location, please include the contact information (name and address).

v. Right to Request Restrictions. You have the right to request in writing that we not use or disclose your medical information unless we have your express consent, it's necessary by law, or there is an emergency. We will take your request into consideration, but we are not legally obligated to grant it, with the exception of specific requests pertaining to disclosures to health insurance. We'll inform you of our decision.

vi. Right to Request Limitations Regarding Disclosures to Health Plans. If disclosure is not required by law and the medical information relates only to a health care item or service for which you (or someone other than the health plan acting on your behalf) have paid us out of pocket and in full at the time of service, you may request in writing that we restrict disclosures of your medical information to a health plan for the purpose of carrying out payment or healthcare operations. If a request satisfies these criteria, we must approve it.

F. Changes to this Notice

This Section may be changed at any moment, with our permission. Modifications will impact healthcare information that we currently possess in addition to newly acquired information following the modification. A copy of our most recent notification will be posted on our website, kirklandemdr.com
